SUPPORT GIVEN TO THE CITY OF BROWNSBURG-CHATHAM REGARDING REQUESTS MADE TO THE MINISTÈRE DES TRANSPORTS ET DE LA MOBILITÉ DURABLE DU QUÉBEC FOLLOWING THE CLOSURE ANNOUNCEMENT OF THE HENRI-RABY BRIDGE

WHEREAS the Henri-Raby Bridge, located on Main Street in the City of Brownsburg-Chatham, was completely closed to all traffic on December 5, 2024.

WHEREAS the bridge belongs to the Ministère des Transports et de la Mobilité durable (MTMD) and that its repair, although planned for more than five years, has been constantly postponed.

WHEREAS during the sudden and unannounced closure of the bridge, the City of Brownsburg-Chatham quickly set up a detour to ensure the continuous and safe flow of traffic within its territory.

WHEREAS the City of Brownsburg-Chatham has requested the reimbursement of costs associated with establishing the detour needed as a result of the unexpected closure of the bridge owned by the MTMD.

WHEREAS the bridge's closure causes several inconveniences for the City of Brownsburg-Chatham, including the accelerated deterioration and additional maintenance of the roads used by the detour, for which compensation has been requested.

WHEREAS the City of Brownsburg-Chatham has required the MTMD to implement a strategy ensuring the safe passage of active transportation users along the bridge.

WHEREAS the Municipal Council of the City of Brownsburg-Chatham has also requested that the MTMD immediately provide them with a clear timeline for the completion of the bridge replacement work;

WHEREAS the Council of the Municipality of the Township of Gore considers it unfair that the MTMD has made the City of Brownsburg-Chatham bear the consequences of postponing the repairs to the Henri-Raby Bridge;

WHEREAS the council of the Municipality of Gore considers the absence of a clear bridge replacement work timeline demonstrates a lack of understanding by the MTMD of the consequences its actions on the City of Brownsburg-Chatham, which must prepare its budgets and work accordingly, as well as answer questions from its citizens:

- requirement to have a clear timeline of the bridge replacement work available to them without delay.
